


# SEPTEMBER 2021 BUTTE-SILVER BOW NEWSLETTER

# IT, GIS, and Economic Development Departments

Butte-Silver Bow will be reaching out to our citizens for help with our Broadband Availability Project. In our research, we have found that much of the data available from the FCC, broadband providers, and other agencies is skewed or incorrect. Working in conjunction with ESRI, and the National League of Cities, we will be creating a website that can be used to survey your broadband needs and measure the existing broadband service at your residence. This will allow us to gather more accurate data, and ultimately provide us with the information needed to produce a realistic map of the speed, affordability, availability, and reliability of the broadband service throughout the county. This information will be used to determine how we will proceed in our efforts to provide equitable, reliable, and affordable broadband to all the citizens of Butte-Silver Bow. ### **Butte-Silver Bow County Coroner**

On several occasions I have been asked, "What is a Coroner?" and, "What do I do?"

A Coroner is an official who investigates death that is sudden, violent, or suspicious. The coroner is an elected position with specific qualifications.

Some of the duties include:

- The county coroner shall hold inquests.
- Inquire into the cause, manner and circumstances of all human deaths and establish identity of the deceased person.
- Provide decent interment or cremation of any unclaimed dead human and unclaimed parts of bodies believed to be human.
- Maintain records of inquires as required by good practice and law.
- As soon as practicable upon identifying a dead human body. provide notification to next of kin.

#### Reclamation and Environmental Services

The Department of Reclamation and Environmental Services staff has been reviewing various superfund documents and preparing for submittal to the regulatory agencies. Staff has been working with Atlantic Richfield to address agency comments regarding previously submitted documents and work plans and incorporating the comments in the final drafts. Field crews have been conducting routine activities. BRES crews have been implementing corrective actions on various reclaimed areas and sediment removals from storm water structures located throughout uptown. The RMAP has been conducting routine environmental assessments and crews have been abating attics on a one per week per crew basis. The RMAP is also remediating residential yards. So far this year the RMAP has completed 64 abatement projects.

Also, staff has been participating in RDRA progress meetings, development and implementation of the Community Engagement Plan and the Repository Siting process.

# Water Utility Division

We get many calls from customers on meters asking, "Why is my water bill so high?" In the summer, you must be careful about the way your underground sprinkling system is set. Be sure it is set to only run on odd or even days based on your address. Be sure you are watering before 10:00 am or after 6:00 pm. Be sure you know how many minutes your system is set to water each zone. The more minutes you water the more gallons of water used. Be sure to check your system for broken sprinkler heads. Some of the other things that cause high readings are toilets that run, leaking faucets, hoses that are left on, children playing with hoses, and washing vehicles.

# **Government Buildings**

The service worker team continues to clean and sanitize Butte - Silver Bow building's daily. With the recent uptick in COVID related cases you will again see spraying of sanitizer increase in your areas. Although not required at this time, masks can go a long way in protecting you and family members. Engineers are awaiting inspections so they can reassemble the boilers and prepare our buildings for the upcoming winter months.

Contracted projects coming up are the LEC/Courthouse boiler replacement and Motherlode fire system installation.

Mobile Home 2nd half 2021 taxes are due September 30, 2021. If you have delinquent Mobile Home taxes, your property is subject to Sheriff Sale. The Treasurer's office will be issuing a WRIT OF EXECUTION to the Sheriff for the collection of delinquent Mobile Home Personal Property Taxes Pursuant to Montana Code Annotated (MCA) 15-16-401 and 15-17-911. The last day to redeem your Mobile Home before the issuance of Writ's will be on September 30, 2021, at which time all delinquent and current year taxes are due to redeem your Mobile Home. After September 30, 2021, an additional Sheriff's fee and Treasurer's fee will be assessed in addition to delinquent taxes, penalty, and interest. ## Finance & Budget Dept.

The City-County of Butte-Silver Bow's budget for fiscal year 2022 was adopted by the Council of Commissioners on August 11, 2021. The total budget for fiscal year 2022 is \$141.7 million. The countywide taxable value \$72,995,269 up 7.03% from the prior year. Residential property taxes, for local government services, will decrease by \$20.25 (3.61%) per \$100,000 in market value. The budget for the tax supported funds is \$54.4 million of which \$28.6 million (52.63%) is funded through property taxes. There are no increases proposed for Water Utility, Metro-Sewer operations, Stormwater, Landfill collection or disposal, or the Countywide Road maintenance district. The Department is finalizing the Fiscal year 2022 Performance Budget and completing fiscal year 2021 yearend processes. The staff is generating financial reports in preparation of the independent audit and completing required

In addition to finalizing the budget and completing year-end processes, the Finance & Budget staff has been attending webinars and trainings related to the American Rescue Plan Act (ARPA) funding relative to the United States Treasury interim guidance on allowable expenditures, and training on the required filings for the direct funding received by the local government under county designation and city portion as a Non-entitlement Unit (NEU). The Department is also working on other grant opportunities from the ARPA funding that was allocated to the State of Montana.

### **Health Department**

Butte-Silver Bow, like the rest of Montana and parts of the country, is experiencing a resurgence in COVID-19 cases. Health Officer Karen Sullivan says the Delta variant to the virus has been detected in the community. In this resurgence, new cases are being confirmed in younger residents, with the median age of active COVID cases, as of Aug. 12, at 29 years. As of Aug. 12, five individuals were hospitalized at St. James Healthcare with the virus, with two of those people in the hospital's intensive care unit. As of Aug. 13, the Health Department was reporting 57 active cases. Of those active cases, 13 are under the age of 12. Fifty-nine percent of Butte-Silver Bow's eligible residents those ages 12 and up – are fully vaccinated, putting Butte-Silver Bow second in the state for vaccination rate. A variety of pop-up vaccination clinics are being held weekly, and residents can visit a variety of local pharmacies to be vaccinated. More information is available at https://www.vaccinefinder.org.
